The tenderer will submit an offer for the implementation and execution of the challenge system in accordance with CEV regulations in this respect. The regulations are attached to this query.

Description of how to prepare offers

The offer should be made in Polish or English in a written form. The offer should be signed by a representative of the potential bidder.

Place and date of submission and opening of offers

Price calculation

The potential bidder should describe the net / gross price of the entire order. Please also specify the potential additional costs that may occur. The price should specify partial prices for business hours of the team, price per match. The Employer does not expect to insure the Contractor's equipment.

Description of criteria that the contracting authority will be guided when choosing the offer

One of the selection criteria will be the price. In addition, the tenderer's experience in similar tournaments will be an important criterion. You must have the appropriate CEV accreditation in this regard. The tenderer should present his experience as an attachment to the offer.

- PZPS does not provide for reimbursement of the any costs of the Contractor's participation in the proceedings.
- The ordering party does not expect to provide for any advance payments for the future implementation of the contract.

Of person representing the potential bidder

1. The following shall be excluded from the procurement procedure:

- a) contractors whose liquidation has been opened or whose bankruptcy has been announced, with the exception of contractors who, after the bankruptcy, have concluded an arrangement approved by a final court order, if the arrangement does not provide for the satisfaction of the creditors by liquidating the bankrupt's assets;
- (b) contractors who are in arrears with payment of taxes, fees or social security or health insurance premiums, except where they have obtained legal exemption, deferral, installment payment of installments or suspension of the full implementation of the decision of the competent authority;
- c) natural persons or companies whose current member of the management body has been convicted of an offense committed in connection with a contract award procedure, offense against the rights of persons pursuing a paid job, environmental crime, bribery, offense against commercial transactions or other offenses committed in to obtain financial benefits, as well as for a fiscal offense or crime of participation in an organized group or a union aimed at committing a fiscal offense or offense;
- d) contractors who performed directly activities related to the preparation of the proceedings or used to prepare an offer with persons participating in these activities, unless the participation of these contractors in the proceedings would not hinder fair competition;
- (f) contractors who have submitted false information that affects or could affect the outcome of the proceedings;
- (g) contractors who have not demonstrated compliance with the conditions for participation in the procedure.
